

April 26, 2017: Village Board Meeting
Minutes of Regular Meeting Sodus Point Village Board

Mayor Tertinek called the regular meeting to order at 7:39 PM and led the Pledge of Allegiance.

MOTION by Trustee Eckberg and seconded by Trustee Kallusch to approve the minutes of the March 16, 2017 regular meeting.

Officer Mackin did report that Officer Cooman is planning on resigning from his position at Sodus Point.

Trustee Eckberg – Ambulance and Community Center

Silver Waters Ambulance Service purchased a Life Pak 15 heart monitor to better their patient care. They received a \$5000 grant to be used for a capital equipment purchase.

The Village of Sodus Point purchased the Life Pak 12 for the ambulance which was traded-in under this purchase therefore

MOTION by Deputy Mayor Kallusch and seconded by Trustee McDowell to surplus the aged out Life Pak 12 and approve the trade in for the upgrade to the Life Pak 15.

Public Comments:

Mr. Sanguedolce from 7562 8th Street reiterated his concerns regarding the standing water in his yard as a result of a sump pump coming from 7558 7th Street. To this point the Village CEO, Village Attorney, Village Engineer, Trustees, Clerks, Mayor and Water, Highway and Sewer departments are all aware of the issue. Unfortunately there is not a quick or easy fix to this issue. The entire Village is currently in a State of Emergency. The Village employees will continue to try to come up with a solution.

A. 2017-4A 2017-18 Budget

The following resolution was offered by Trustee McDowell, seconded by Mayor Tertinek adopting a budget for the fiscal year commencing June 1, 2017 and ending May 31, 2018, making appropriation for the conduct of Village of Sodus Point Government and establishing the rates of compensation of officer and employees for such period presented

WHEREAS, this board has met April 26, 2017, at 6:45 PM in the Village Hall, 8356 Bay Street, Sodus Point, NY the time and place specified in the notice of public hearing on the preliminary budget and heard all persons desiring to be heard thereon; now, therefore, be it

RESOLVED, that the preliminary budget as amended and revised and as hereinafter set forth is hereby adopted and that the several amounts stated in the column titled "Adopted in Schedule A1, Schedule F1 and Schedule G1 be and they hereby are appropriated for the objects and purposes specified and the salaries and wages of such budget shall be and are hereby fixed at the amounts shown therein effective June 1, 2017

B. The Wastewater Department received quotes for the Clover Street pump station repairs.

*Koester Assoc. quoted a total price of \$13,656.76 which includes parts and removing and replace discharge piping:

*Blue Heron Construction quoted a total price of \$11,500 which did not include the price of parts. The Village would be responsible for the purchase.

MOTION by Deputy Mayor Kallusch and seconded by Trustee Eckberg to approve the quote from Koester Assoc. in the amount of \$13,656.76.

C. The contract for the lease with Toshiba is expiring 6/25/17.

Toshiba quoted a new 60month proposal upgrading our machine to a color copier with all of the same features we currently receive. The current monthly lease amount is \$135.16. The proposed monthly lease amount will be \$132.83 for the first year. The amount of increase will be 5% per year for the length of the contract.

MOTION by Deputy Mayor Kallusch and seconded by Trustee Eckberg to approve the 60 month lease with Toshiba Business Solutions for the upgrade to the e-Studio 2500AC Color MFP.

D. MOTION by Trustee Kennedy and seconded by Trustee McDowell to approve the Contract for Staffing Services with E.M.S Staffing starting June 1, 2017 through May 31, 2018. The cost of the services for Staffing shall be \$43,448.92 annual or \$3,620.74 monthly for Monday-Friday 8am-4pm and Saturday and Sunday 10am-6pm.
